## History

Anudip Foundation for Social Welfare was set up in May 2006 through the initiative of Dipak Basu, Radha Basu, Ganesh Natesan and Alakananda Rao. They left their distinguished corporate roles to pursue social welfare activities in eastern India and have built up the organization into a successful social enterprise. Anudip founders brought their knowledge and experience in information technology and general management and their understanding of the needs of marginalized rural populations to focus on "livelihood initiatives through knowledge" which is Anudip's vision.

Anudip Foundation is registered as a section 25, non-profit limited Company under the companies Act 1956, based in Kolkata.

# Vision

To bring IT based prosperity to rural and semi-urban areas and provided enhanced livelihoods to the poor and underserved population.

## Programs

## MAST

Anudip creates enhanced livelihoods for the unemployed and marginalized poor through a chain of Market Aligned Skills Training centers which offer in-depth skillbuilding in IT, spoken English, job readiness and entrepreneurship to develop skilled professionals and business owners. All training courses are conducted in partnership with community NGOs. Anudip provides course content, training equipment and instructors while partner NGOs provide classroom facilities and together mobilize students through community linkages. Courses are offered for a nominal fee which help NGO-partners recover their costs. Anudip collaborates with reputed organizations like Microsoft, American India Foundation and EduLever to offer the courses customized for its rural students who have no prior familiarity with computers or the business world.

# DREAM

Through its Developing Rural Entrepreneurs Through Adoption and Mentoring program, Anudip assists its graduates who are interested in starting group-based microenterprises, provides them with equipment on lease (computers, printers, cameras, etc.), mentors them during business incubation phase with guidance in planning, marketing and budgeting and monitors the businesses' progress and provides on-going support to help them grow.

# MERIT

Anudip offers a scalable team of professionals, trained through MAST, to assist clients with outsourced business needs. Anudip adapts to new-age IT environments by providing services for social media, cloud-computing and web-based businesses. Through deployment of MERIT program surpluses Anudip is on its way to a sustainable social enterprise.

# **Chairman's Report**

The Directors present the Second Annual Report together with the Audited Accounts of the Company for the financial year ended 31<sup>st</sup> March 2011.

# FINANCIAL RESULTS

The Company received the license under section 25 of the Companies Act, 1956 on 12<sup>th</sup> March, 2007 from the Regional Director, Eastern Region, Ministry of Company Affairs, Kolkata, and obtained the certificate of incorporation dated 31<sup>st</sup> May, 2007 from the office of the Registrar of Companies, West Bengal.

Thereafter, the Company commenced its activities. During the financial year ending on 31<sup>st</sup> March, 2011, the Company's net financial result shows an Excess expenditure over Income of Rs. 17,50,416, after providing depreciation on assets acquired amounting to Rs. 1,30,436. This surplus represents unutilized balance of fund received for meeting the main object of company. However, on the date of this report, the entire surplus has been utilized for social causes.



# **OPERATIONS AND PERFORMANCE**

During the fiscal year under review, the Company expanded its training operations by adding new courses such as Entrepreneurship Development and Hardware Maintenance, by recruiting additional trainers and opening MAST training centers at several new locations, bringing the total number of such centers to 18.

The number of students that graduated from our MAST Centers at the end of the fiscal year stood certified 756 and enrolled 1234. The cumulative number of students trained has surpassed 5000.



Anudip launched its operational MERIT center for delivery of projects in January, 2010 with Anindya Chattopadhyay assuming the role of General Manager. Also in January 2010 the Company began operations in North Bengal with 3 MAST centers in Jalpaiguri district projected to train 100 students each. Late in the year the Company began preparations to recast its training with a greater focus on maximizing job placement of its students.

#### SCHEDULE - X SIGNIFICANT ACCOUNTING POLICIES AND NOTES ON ACCOUNT

#### A. SIGNIFICANT ACCOUNTING POLICIES:

 <u>Basis of Accounting</u> All expenses, unless specially stated to be otherwise, have been accounted for on mercantile basis and all income on receipted basis, and are consistent with generally accepted accounting policies.

2. Fixed Assets

Fixed Assets have been stated at cost of acquisition.

3. Depreciation

Depreciation on fixed assets has been provided on written down value method at the rates as per Schedule XIV to the Companies Act, 1956, and in the manner provided therein.

4. Other Accounting Standards shall be formulated as and when the same are applicable.

#### B. NOTES ON ACCOUNT:

- 1. Previous years figures have been re-grouped or rearranged where ever necessary.
- 2. Preliminary Expenses, relating to formation of the Company, is to be amortize over a period of five years.
- 3. During the year under consideration, the Company has received Rs.53,99,085 in foreign currency as Donation, equivalent to \$ (U.S.) 119,865 at an average rate of conversion of Rs.45.10 per \$.
- 4. No remuneration or profit has been paid to any Director of the Company.
- 5. During the year under consideration, the Company had received 50 nos. (fifty) number of computers and monitors with accessories from Capgemini India Private Ltd. The value of the said computers, as state in the invoice, were taken to be nil and thus not included in the block of fixed assets. All the computers were in turn handed over to various training centers free of cost.
